TAMBA Board Application Process

Following is the process, requirements, and schedule to apply for a TAMBA Board position.

By November 22nd, please email the following to the Selection Committee (scott@tamba.org):

1. Submit a one-page resumé or similar document that provides an overview of your professional experience and education.
2. Provide answers to the following questions. Please limit each answer to a single paragraph.
 - a. Why are you interested in being on the TAMBA Board?
 - b. Which strategies of TAMBA's 2020 Strategic Plan do you think you could help implement and why?
 - c. From your perspective, what does TAMBA do well and what could we do better?
 - d. What skills make you well suited to be on the TAMBA Board? Specifically, which role(s) delineated in the TAMBA Board Handbook are you most interested in taking on?
 - e. What fundraising background or experience do you have?
 - f. On average, you can expect to spend a minimum of 1 to 3 hours a week on TAMBA-related tasks. What other personal and professional commitments do you have, and are you confident you have the time for TAMBA?

Between December 3rd and December 11th, please be available to participate in a video conference interview with the current TAMBA Board.

Selections and notification will be made before December 18th.
